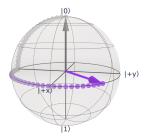

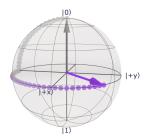

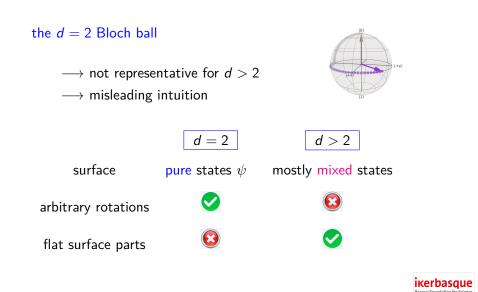
unfortunately . . . the qubit Bloch ball

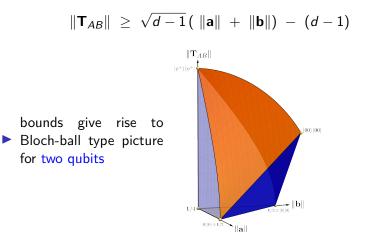

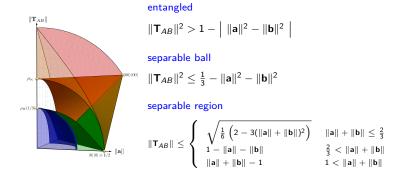
